

**ORDINANCE NO. 2023-1**

AN ORDINANCE AMENDING ORDINANCE NO. 2022-6 (ENTITLED: AN ORDINANCE ADOPTED PURSUANT TO ACT 1112 OF 2017, APPROVING THE APPLICATION OF TELINGA'S MEX LLC FOR A PRIVATE CLUB TO BE LOCATED AT 100 E. 13th St, MUFREESBORO, AR 71958)

**WHEREAS**, Murfreesboro City Ordinance No. 2022-6 was passed on December 12, 2022, for the purpose of approving the application of Telinga's Mex, LLC for a private club license; and

**WHEREAS**, Telinga's Mex, LLC would like to change their application to the name of Childers Corner Social Club Inc. d/b/a Telinga's Mex Restaurant; and

**WHEREAS**, Act 1112 of 2017 requires applicants for private club licenses to obtain approval of the governing body of the city where the club is to be located; and

**WHEREAS**, Childers Corner Social Club Inc. d/b/a Telinga's Mex Restaurant has requested the City Council of the City of Murfreesboro to serve alcoholic beverages within the permitted premises at 100 E. 13th St, Murfreesboro, AR 71958; and

**WHEREAS**, the City Council of the City of Murfreesboro, Arkansas, has considered the request of Childers Corner Social Club Inc. d/b/a Telinga's Mex Restaurant and finds the request will promote the public convenience and advantage to provide community hospitality and increase sales tax revenue in the city.

Now therefore, be it ordained by the City Council of the City of Murfreesboro, Pike County, Arkansas:

**Section I.** The request of Childers Corner Social Club Inc. d/b/a Telinga's Mex Restaurant for approval of a private club license in conjunction with a restaurant operated at 100 E. 13th St, Murfreesboro, Pike County, Arkansas, be, and it hereby is, approved by the City Council of the City of Murfreesboro, Arkansas.

**Section II.** Pursuant to Act 1112 of 2017, Childers Corner Social Club Inc. d/b/a Telinga's Mex Restaurant, is hereby authorized to file a private club application with the Department of Finance and Administration, Alcoholic Beverage Control Division, for the location at 100 E. 13th St, Murfreesboro, Pike County, Arkansas. A copy of this Ordinance shall be provided to the Alcoholic Beverage Control Division of the Department of Finance and Administration as evidence of the City Council Approval.


**Section III.** The serving of alcoholic beverages shall be for members and guests of the private club doing business at Childers Corner Social Club Inc. d/b/a Telinga's Mex Restaurant pursuant to Arkansas law.

**Section IV.** All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**Section V.** As this ordinance concerns a matter affecting the lives and property of the citizens of Murfreesboro, specifically the right of community hospitality among the citizens of Murfreesboro, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect from and after the date of its passage and approval.
